
Banco Comercial Português informa sobre participação qualificada do Norges Bank

De acordo com o artigo 17º do Código dos Valores Mobiliários, o Banco Comercial Português, S.A. (BCP) informa ter recebido no dia 25 de abril de 2016, uma comunicação do Norges Bank, reproduzida em anexo, a informar que a 22 de abril de 2016, passou a ter uma participação qualificada no BCP, composta por 2.290.293.671 ações representativas de 3,88% do capital social do BCP.

Das 2.290.293.671 ações detidas pelo Norges Bank, 1.214.568.024 ações são detidas diretamente, representam 2,06% do capital social do BCP, sendo as remanescentes 1.075.725.647 ações imputáveis através de instrumentos financeiros, nomeadamente através de um instrumento financeiro do tipo "shares on loan (right to recall)".
