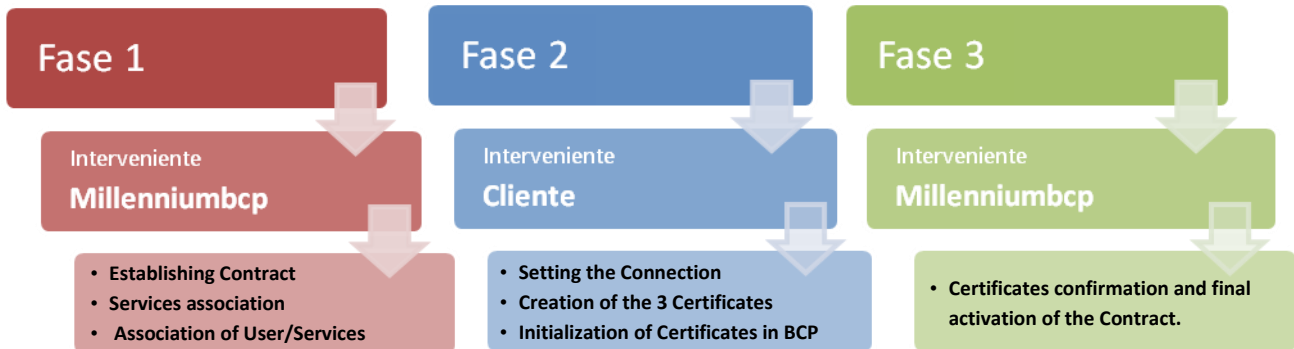


Canal Multibancário Services

Millennium bcp will proceed to open port 4500 so that the Customer IP has access to the server. If the integration partner is Metacase, the respective IPs already have access.
